Debt Recovery Scheme

The Debt Recovery Scheme is designed to take away the valuable time and effort that a business expends in chasing undisputed invoices.

Palmers Solicitors is able to assist in a cost proportionate way at all stages of the debt recovery process. Often all that is needed is for a debtor to receive a letter from a solicitor to demonstrate to them that a business is serious about debt recovery. Palmers Solicitors can therefore escalate the debt recovery process by drafting a formal letter before claim to ensure compliance with the Practice Direction on Pre-Action Conduct and, if required, draft a Claim Form and Particulars of claim to prepare proceedings for issue, all for a fixed and proportionate sum.

It is the choice of the business involved whether to progress from option a to b and you retain control of that decision. (In the event that the invoice is disputed ordinary hourly rate charges will apply and that information will be provided at the relevant time – see the Debt Recovery Scheme for more information.)
